ARTICLE V – DUTIES OF OFFICERS AND EXECUTIVE BOARD

<u>Section 1:</u> The **Colony Governor** shall preside at all meetings; shall act at all times as the chief executive officer of the Colony; shall appoint (with the approval of the other elected officers) all committees not otherwise provided for; shall attend the Board of Assistants meetings whenever possible; shall be an ex-officio member of all committees except the Nominating Committee; and shall notify Secretary of any new members.

<u>Section 2:</u> The **Colony Deputy Governor** shall, in the absence of the Colony Governor, perform the duties of Colony Governor, and, in addition, shall, as Program Chair, arrange and obtain speakers and locations for all Colony meetings.

Section 3: The Colony Secretary shall: (a) keep the minutes of the Colony and the Executive Board; (b) email, or snail mail, copies of the minutes of the general meetings within two weeks after each meeting to members of the colony and the State Secretary. The board meeting minutes will be summarized in the newsletter. (c) shall email a news blurb to the Editor of the California Mayflower Quarterly in a timely manner; (d) maintain a current roster of colony members; (e) conduct such correspondence as requested by the Colony Governor or by the Executive Board; and (f) email, or snail mail, a copy of the newsletter to members, as well as, the CA Governor and the CA Deputy Governor North. The Colony Secretary welcomes new prospective members and interested guests, as well as new members, to our Colony.

<u>Section 4:</u> The **Colony Membership Chair**(CMC)shall (a) call the roll of Ancestors at each regular meeting of the Colony. This roll call will be a simple raising of the hand once, for each ancestor line.; (b) assist members and prospective members with applications and lineage papers; (c) notify secretary of new members; (d) Notify the State Society without delay, of any changes in the vital statistics of members.

Section 5: The Colony Treasurer shall receive all funds of the Colony and shall deposit them in such bank as may be designated by the Colony. He/she shall disburse these funds only as directed by the Colony or Executive Board. In case of inability of the Colony Treasurer to sign checks, the Colony Governor's signature will be honored, and the bank notified immediately of this situation. The accounts shall be reviewed annually by a non-Board member appointed by the Colony Governor. The fiscal year of the Colony shall end each year with December 31. Each year the Colony Treasurer shall render promptly to the members a full and detailed report of all receipts and disbursements during the preceding year. The Colony Treasurer will compile a report as requested by the State Treasurer summarizing the year's receipts and expenses.

<u>Section 6:</u> The **Colony Chaplain** shall open all meetings of the Colony with a reading of prayer and shall conduct such memorial services as the occasion may require. The Colony Chaplain shall communicate, whenever possible, with members who are ill or in distress and shall keep an accurate list of all deceased members. The Chaplain will send a letter of condolence to families of those members who have died.

<u>Section 7:</u> The **Colony Delegate** shall act as Colony representative to the meetings of the Board of Assistants of the Society of Mayflower Descendants in the State of California, Inc. if the Governor cannot attend, or if the Governor holds an office on the State Executive Committee. An Alternate Delegate may be appointed if neither the Delegate or Governor can attend.

<u>Section 8:</u> The **Colony Archivist** shall maintain former records and advise of historically interesting items.

<u>Section 9:</u> The **Executive Board** (consisting of all eight officers plus two committee chairs) shall have authority over the affairs of the Colony between meetings. Executive Board meetings shall be at the call of the Governor or Deputy Governor and may be held on a digital device such as zoom or by telephone, or email. Four members shall constitute a quorum. The Executive Board shall be subject to the orders of the Colony, and none of its acts shall conflict with a duly held, lawful vote of Colony members.
